

GREATER VANCOUVER TRANSPORTATION AUTHORITY
BY-LAW NUMBER 30-2003

A By-Law to amend the Greater Vancouver Transportation Authority 2001 Tariff
Amendment By-Law Number 22-2001 (as amended)

WHEREAS the Greater Vancouver Transportation Authority (GVTA) has approved expanded hours of operation for West Coast Express utilizing a TrainBus.

WHEREAS the creation of new fare media for the existing FastTrax program necessitates amendments to the Greater Vancouver Transportation Authority Transit Tariff (the "Transit Tariff").

NOW THEREFORE the Board of Directors of the Greater Vancouver Transportation Authority enacts as follows:

The Greater Vancouver Transportation Authority Transit Tariff annexed to the "Greater Vancouver Transportation Authority 2001 Tariff Amendment By Law No.22-2001", is hereby amended as follows:

1. Part 3 – West Coast Express, Section I – Terms and Conditions – Delete the following section on **28-day Pass** in its entirety:

28-Day Pass A 28-Day Pass, including a 28-day U-Pass pass, is valid for 28 calendar days, including intervening weekends and statutory holidays, for any West Coast Express train and transfer and unlimited travel on all GVTA transit services, up to and including the date of expiry.

and replace it with the following:

28-Day Pass A 28-Day Pass, including a 28-Day U-Pass pass *and a 28-Day FastTrax Pass*, is valid for 28 calendar days, including intervening weekends and statutory holidays, *on* any West Coast Express *service* and transfer and unlimited travel on all GVTA transit services, up to and including the date of expiry.

2. Part 3 – West Coast Express, Section I – Terms and Conditions – Delete the following sections on the applicability of FastTrax and fare payable in their entirety:

Applicability To any full-time student at an eligible public post-secondary institution designated by GVTA who is in possession of valid FastTrax identification issued by GVTA for purchase of a 28-day pass only. Valid from September 1 to August 31. Not valid for concession fare.

Fare Two zone (\$105.00) pass valid for travel in all zones.

and replace it with the following:

Applicability	To any full-time student at an eligible public post-secondary institution designated by GVTA who is in possession of valid FastTrax identification issued by GVTA for purchase of a 28-day <i>FastTrax</i> pass only, <i>valid for travel in all zones</i> . Valid from September 1 to August 31. Not valid for concession fare <i>or add fare</i> .
Fare	<i>28-Day FastTrax pass for the price of an adult two-zone 28-day pass.</i>

3. Part 3 – West Coast Express, Section I – Terms and Conditions – Delete the following subsections (i) and (ii) of **One Way Ticket Entitlement** in their entirety:

One Way Ticket Entitlement	(i) AM issued ticket is valid for one-way trip on any West Coast Express train, plus transfer and unlimited travel on all GVTA transit services from 5 a.m. to 10 a.m. up to and including the date of expiry.
	(ii) PM issued ticket is valid for one-way trip on any West Coast Express train, plus transfer and unlimited travel on all GVTA transit services from 3 p.m. to 8 p.m. up to and including the date of expiry.

and replace it with the following:

One Way Ticket Entitlement	Issued ticket is valid for one-way trip on any West Coast Express <i>service</i> , plus transfer and unlimited travel on all GVTA transit services <i>for 180 minutes from time of purchase</i> . <i>Valid until the expiry date and time shown on the ticket.</i>
